1. Iowa Falls Prevention Coalition – Trina Radske-Suchan

- See attached slides for History and Action Plans
 - Vision: lowans will have fewer falls and fall related injuries, maximizing their independence and quality of life.
 - Mission: To facilitate collaboration among state, community, and healthcare system partners to reduce falls by building awareness, providing education and supporting implementation of falls prevention efforts.
- Welcomes additions to the state fall prevention coalition as well as state working groups
- Vision for Story County Falls Prevention Coalition as potential model for other counties in Iowa.

2. Walk With Ease Project – Greg Welk

- Funded CDC trial goals include evaluating the potential of Walk with Ease for falls prevention, building sustainable falls prevention programming and piloting strategies for clinical/ community integration.

3. Overview of the Iowa Community HUB – Trina Radske-Suchan and Joy Doll

- HUB uses PRAPARE tool and can assist health systems with SDOH screening and referral

- HUB partners with Civitas Networks for Health, a national collaborative working with the Gravity Project validating standardized SDOH data and integration with EPIC

4. Update on Clinical and County Falls Prevention Efforts

- Inpatient / Primary Care Matt Aitchison reviewed history and current best practices with fall
 prevention focus since 2010. Daily focus on falls prevention during rounds is standard practice
 and monthly meetings with coaching to discuss best practices and education is a part of the
 hospital's comprehensive approach. Working together on a county falls prevention coalition
 with evidence-based interventions is welcomed.
- Emergency Room Tricia Colman shared the need for falls prevention in the community with falls being the number one cause of injury. She shared commitment from Dr. Flugrad and mentioned looking forward to promoting falls prevention referrals and education.
- Home Health / Story County Public Health Les White / Eric Adelmund provided information focused on county falls prevention and do falls prevention screening on all patients. They mention the possibility of collaboration through technology. Senior Health Clinics on site are potential sites for falls prevention screening.
- Story County Extension has facilitated communications and promotions of falls screening and is working to formalize a county affiliation with the Iowa Community HUB.
- Physical Therapy Matt Petersen reviewed the innovative falls prevention technologies such as virtual reality, use of balance platforms and vertigo specialists along with Walk With Ease research positioning Mary Greeley Medical Center with niche expertise.

5. Reflections and Open Discussion

- Promote awareness of fall risk issues among clinicians, organizations and individuals
- Facilitate clinical / community integration to foster referrals and bidirectional feedback
- Establish procedures for monitoring and tracking fall risks and outcomes over time
- Discussions
 - Dr. Welk shared plans and a flyer for the upcoming Falls Risk Screening event on January 9 (1:30-3:30 in Atrium A, MGMC) as an event of the Story County Falls Prevention Coalition.
 - Dr. Welk mentioned an upcoming meeting with IT specialists from McFarland and MGMC to explore integration of the PA Vital Signs (PAVS) and the recommended PROMIS tools (Pain / Function) from the national arthritis care model. Formalized integration would enable direct referrals and bidirectional feedback for enhanced value-based care.  - Dr. Kitchell asked about GUIDE (Guiding a New Dementia Experience Model). Discussion covered the importance and applications are due 1/20/2024 (for health systems applying, the HUB could potentially be a partner in grant activities).
