Collectively we aim to reduce the risks and prevalence of falls at a population level. This requires a community-based approach. Our formalized Story County Falls Prevention Coalition creates the needed infrastructure to enhance clinical / community collaboration and optimize effectiveness.

1. Story County Falls Prevention Coalition - Colleen Schwartz

- Announced that all action items from November 23, 2023 meeting were completed.
- Discussed vision for Story County Fall Prevention Coalition to reflect locally the state vision of: lowans will have fewer falls and fall related injuries, maximizing their independence and quality of life.
- Announced Iowa Falls Prevention Coalition Meeting is 3/14/24 8:30am-10am. All welcome.
- Presented state of Iowa and Story County hospitalizations and emergency department visits for fall related injuries- 2022
- Discussed proposed Story County Fall Prevention Coalition Goals & Roles
 - o Promote Fall Risk Screening in the Community
 - o Promote awareness of fall risk issues among clinicians, organizations and individuals
 - o Facilitate clinical / community integration to foster referrals and bi-directional feedback.
 - o Facilitate direct referrals through the Iowa Community HUB.

o Establish procedures for monitoring and tracking fall risks and outcomes over time

2. Update & Discussion on Clinical and County Fall Prevention Efforts

- <u>Inpatient / Primary Care</u> Matt Aitchison / Amy Schweers updated on decreasing injury with use of Fall Max. Discussed Hester Davis Fall monthly reports, evidence-based tool, with approximately 90% accurate scoring documenting age, past medical history and diagnosis. Medication is a significant consideration in fall risk.
- <u>Emergency Room</u> Tricia Colman / Sherri Flugrad Discussed major factor of substance use and polypharmacy in falls and fall prevention. Spoke of increasing awareness of EPIC referrals to fall prevention programs/ Walk With Ease through the ER.
- Home Health / Story County Public Health Eric Adelmund discussed successful Fall No More Program offering financial assistance to patients for devices such as walkers and reachers. He discussed Story County Public Health Keys Program and promoting fitness. He encouraged public health screens with fall risk and connection with Seniors in Story
- <u>MGMC Physical Therapy</u> Matt Petersen has led PT component of community fall screenings x 2 in past month and encouraged increased frequency and opportunities for collaboration with Story County Public Health. Additional meetings between Matt, Eric and Greg were planned.
- Walk with Ease Update Clinical Trial Greg Welk / Matt Petersen
 - o Greg provided an update on registrations and enrollment in the trial and introduced new evaluation and exercise prescription strategies developed by the PT team
 - o Matt shared additional information on the process and the focus on balance and the advantages of this for community-based programming like WWE.
- <u>Story County Fall Risk Screening</u>- Greg provided a brief update on the successful January and February Screening Events and indicated that efforts are needed to reach minority and at-risk populations that are harder to reach. Events outside of Ames may be needed.
- <u>Updated on the Iowa Community HUB</u> Trina provided an update on the HUB infrastructure and partnerships for promoting more referrals. See slides.
- <u>STEADI Fall Risk Training Course</u> Greg provided a brief update on the free online training course that his team developed which is now distributed through ISU Extension. Greg and Colleen will be working to enable completion of the course to count for CME and plan to work with ISU Extension and the HUB to enable further sharing of the training.

3. Reflections and Open Discussion

- Dr. Kitchell brought up strategies for referral promotion to trigger BPA in EPIC after fall risk establishment in over 65 population. Dr. Kitchell suggests Bare Bones / newsletter article outreach to medical community. Also grand rounds with hybrid option good to promote updates on fall prevention. Also interested in how the age adjusted data in state of lowa Falls data is determined.
- Jenni Talbott encouraged Bare Bones and possible Grand Rounds video. Discussed upcoming discussion on best practices for workflow possibly identifying hip and/or knee arthritis to connect BPA to Hub / Fall Prevention. Meeting 12pm 2/29/24.
